

**RESOLUTION NO. 2018- \_\_\_\_**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ORLAND  
CALIFORNIA, AMENDING BALLOT LANGUAGE OF MEASURE E**

**WHEREAS**, on July 2, 2018, the City Council of the City of Orland approved ballot language for a Measure to be placed before the District's voters for the November 6, 2018 election; and,

**WHEREAS**, the City Council seeks to amend this language.

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF ORLAND, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

Section 1. The City Council finds that all of the forgoing recitals are true and correct and are hereby incorporated and adopted as findings and determinations by the City Council as if fully set forth herein.

Section 2. The City Council, pursuant to its right and authority, does order submitted to the voters at the General Municipal Election the following question:

<b>MEASURE E: APPROVING AN INCREASE TO THE HOTEL USERS TAX OF THE CITY OF ORLAND</b>	<b>YES</b>	
Shall Measure E be adopted to approve an increase in the City's Hotel Users Tax from the current rate of ten percent (10%) to a rate of twelve percent (12%), raising \$30,000 annually, all funds staying local for the direct benefit of services for the citizens of the City of Orland, including law enforcement, emergency medical and fire, street repairs, and supporting Orland's tourism, the duration of the tax continuous, until repealed or amended?	<b>NO</b>
