MINIMUM CHARGE = \$ 15.00 (UP TO 425 LBS.)

Additional items and all others pay the following fees:  Loads of more than 9 whole tires must present a tire hauling manifest. Additional items and all others pay the following fees (weight fee waived):</p> <p>1. Refrigeration units (Refrigerators, freezers, air-conditioners, etc.)</p> <p style="margin-left: 20px;">a. Washers, dryers, dishwashers, stoves, hot water heaters, space heaters, boilers, furnaces                      \$10.00 ea.</p>	<p>F. <u>BULKY AND HARD TO HANDLE ITEMS</u> County residents who produce either a current bill from a County authorized waste collector or two gate receipts (not more than 60 days old) may dispose of one bulky/hard to handle item per visit at no charge. Additional items and all others pay the following fees in addition to the weight fee:</p> <p>1. Mattresses, box-springs, hide-a-beds, couches, recliners, etc.                      \$ 5.00 ea.</p> <p>2. Other Bulky / Hard to Handle (stumps &gt;24", irrigation tubing &gt; 48")                      \$15.00 ea.</p> <p>G. <u>DEAD ANIMALS (by appointment only)</u> Fees may be waived for County-authorized animal shelter. Inquire within. Animal carcasses in excess of 150# ea are not accepted at any time.</p> <p>1. Small (&lt;50#)                      \$ 5.00 ea.</p> <p>2. Medium (50# to 100#)                      \$10.00 ea.</p> <p>3. Large (100# to 150#)                      \$25.00 ea</p> <p>H. <u>RECYCLING DROP-OFF CENTER:</u>                      FREE</p> <p>1. Aluminum, glass, plastic, paper, cardboard</p> <p>2. Antifreeze, Batteries, Oil &amp; Oil Filters, Paint</p> <p>3. Clean Scrap Metal &amp; Steel – no oil, compressor oil, fuel, mercury switches, mercury thermostats.</p> <p>4. Computers, televisions, monitors, misc e-waste</p> <p>5. Batteries (all kinds, must be sorted and terminals covered)</p> <p>6. Ag Plastics (triple rinsed, dry, all metal and rubber removed, drums cut into quarters crosswise or lengthwise) We can no longer accept plastic pesticide containers of any size as trash. K. ADDITIONAL FEES:

1. Extra handling fees of \$50 per hour (minimum one hour) will be applied to the following:

- a. Contaminated recycling
- b. Compromised roll offs (Individuals renting roll off containers are responsible for payments for any and all materials present when the load is dumped. You will be billed for any appliances as noted above, as well as a \$50 per HOUR charge for landfill staff to remove the electronics, appliances, hazardous waste, paint, oil, batteries, or other materials that are required to be kept out of the landfill. It is your responsibility to closely control access to your roll off container in order to protect yourself from extra dump charges THAT WILL BE PASSED ON TO YOU BY THE HAULER.)
- c. Spilled loads.
- d. Contaminated loads – grossly unsorted loads containing banned materials; Also applies to roll-off loads containing banned items (see b. above).
- e. Customers who are non-compliant with County Code and/or posted policies..
- f. Drive-off (leave without payment).
- g. Difficult to cover loads such as loose plastic film, mulch, long lengths of plastic irrigation tubing, branches, etc. (> 4' lengths).
- h. Other materials/loads as determined by Solid Waste Division Management.

2. Uncovered Load \$10.00  
Customers who arrive at the landfill with their load uncovered may be assessed this fee.

3. Customers caught removing items from the landfill who refuse to comply with staff direction to return the scavenged items(s) will be subject to the extra handling fee of \$50 per hour (one hour minimum) and may only have restricted access to the landfill site on future visits.
