Workshop was called to order by Chairman Campbell. Workshop opened with the Pledge of Allegiance.

PUBLIC COMMENT

Jim Yoder and Sandie Hobbs, Councilmembers from the City of Willows, expressed their interest in economic development and partnering with the City of Orland during these difficult economic times. Council and Commissioners agreed working together is a great idea and to include the County in their collaboration.

WORKSHOP –

To discuss and clarify the City Council's expectations of the Economic Development Commission's responsibilities, goals and/or objectives.

Vice Chairman Duree request the Economic Development Commission (EDC) be given specifics tasks to be performed.

Chairman Campbell felt focus needs to be given to the I-5 corridor. Chairman Campbell asked Council what was their plan or vision for the City of Orland; big box store, small business or manufacturing.

Council and commissioners discussed sustaining and supporting our local business, as well as collaborating with the school district. Councilmember Roundy advised there is joint effort between the City and the school district to apply for a grant to develop a 10 acre park with educational components. Councilmember Roundy stated improvements to the local swimming pool should also be considered as it would bring larger events to the community.

It was agreed upon, that the City needs to meet with representatives from the County regarding possible uses of the airport and to encourage communication between the two entities. Council stated agricultural related business, open space and solar energy is viable to the entire community.

Councilmember Hoffman advised the City should be here to help remove any roadblocks and remain positive.

Councilmember Gee questioned changes to the 2010 Building Code that would allow for exemptions to small business in regards to ADA requirements.

Brandy Branzelle advised Council and Commissioners of a possible viable business using the byproducts from olive processing.

- Beautify I-5 corridor
- Work with the County to form a County EDC
