ORAL AND WRITTEN COMMUNICATIONS

Citizen Business:

Judy Noffsinger, 4261 Co. Rd MM reminded everyone to come to the Art Show opening, held at the Art Gallery, Friday August 5, from 3:00 p.m. to 7:00 p.m. Medina Branzelle, 322 Bryon Way, thanked staff and Councilmembers for clarifying the close out of Grant No. 08—PTAG-5350 (Housing Element Update). Forrest Sprague, Artois, stated he wanted the Council to take into consideration while evaluating the City Manager that he regularly attends economic development related meetings in the area and does a good job of representing Orland.

PUBLIC HEARING

1. Conduct a Public Hearing to provide public comments for close out of Grant No. 08-PTAG-5350 (Housing Element Update)

City Manager Poczobut stated the hearing was to hear comments on procedures that were conducted for the implementation of the grant. Grants Administrator Wackerman stated there were no written comments received regarding the grant but she had received a few inquiries that were related to the Housing Element.

Mayor Paschal opened the public hearing at 7:41 p.m. Bob Bishop, 224 Mellane Circle, did not comment on the grant but commented on the Housing Element; stating he thought it was a flawed document. Interim City Attorney Andrews stated the Housing Element document is not being addressed under this agenda item. There were no further comments and the Public Hearing was closed at 7:50 p.m.

Council member Gee stated that the matter before the Council did not pertain to the General Plan or the Housing Element but was for comments on the grant.

Upon motion made by Councilmember Gee and seconded by Councilmember Hoffman, the City Manager was authorized to sign and submit the close-out documents to the California Development Block Grant Program for Grant No. 08-PTAG-5350. The motion carried with no abstentions.

City Manager Poczobut request Council to consider application (Type-21) and Findings for Public Convenience or Necessity for Alcoholic Beverage Control License for 7 Eleven, located at 131 E. Walker Street, Orland; applicant – 7 Eleven, Inc. , Dharminder Singh Janda.

Mr. Janda stated he wanted to add to the community of Orland a 7-Eleven convenience store in the Sapphire Plaza Shopping Center. He stated it would be open 24 hours and include over-the-counter medications, health products, and fresh and hot food varieties. A few Orland residents expressed their concerns for having another convenience store opened 24 hours while others welcomed the opportunity for another business in Orland.

Vice Mayor Elliott moved, seconded by Councilmember Hoffman to approve the application (Type-21) and Findings for Public Convenience or Necessity for Alcoholic Beverage Control License for 7 Eleven, located at 131 E. Walker Street, Orland; applicant 7 Eleven , Inc., Dharminder Singh Janda. Motion carried with no abstentions.

City Manager Poczobut gave an update on the City Attorney proposals. Councilmember Gee along with Councilmember Roundy stated that they would like the Council as a whole, interview the top three applicants and participate in the hire of the new City Attorney.
