ADMINISTRATIVE BUSINESS

City Manager:

City Manager Carr presented to Council the draft City response to the 2014-2015 Glenn County Grand Jury report. The Grand Jury report stated the Orland Volunteer Fire Department (OVFD) is commended for its exceptional work in the community; however, they identified having a need for improved long-term funding for equipment replacement.

Councilmember Hoffman moved, seconded by Vice Mayor Edwards to approve draft letter in response to the 2014-2015 Glenn County Grand Jury report. The motion carried by the following voice vote:

Councilmember Gee noted the OVFD and Rural Fire department should possibly consider a combined proposal for long-term funding. Chief Caster advised discussion is occurring between the two boards on whether it would be beneficial to consider.

City Manager Carr presented the Orland High Swim Team proposal for use of pool facilities during the remainder of the normal swim season. The Orland Unified School District has indicated interest in restarting a swim team and the pool's possible use for physical education classes. City staff advised pool expenses may run between \$4,000-\$7,500. A group of parents have stated interest in organizing and paying up to but not to exceed \$3,000 for use of the facilities this year, until the OUSD district can consider in the next budget year. Recreation Director Fenske stated the City could also provide pool recreational programs during this time, weather and lifeguard dependent. Tracey Quarne, Glenn County Superintendent of Schools, spoke in favor of the efforts between the school and the community. Council had concerns of liability issues, which staff advised fall under OUSD. Mayor Paschall stated if the OUSD decides to proceed next year, they should bear costs beyond what the parents can invest.

Councilmember Gee moved, seconded by Councilmember Hoffman to approve proposal for use of City pool for Orland High Swim team 2015 at a cost not to exceed \$3,000; with item to be forwarded to Orland School board for consideration in their next year's budget. City Manager Carr requested Council to consider an exchange of certain real property (APN 041-140-043-0) interest at the Linwood Subdivision for easement rights to construct a bike/ped pathway between the subdivision and Road 15. The City could direct pathway users east or west and explore a possible south extension of the pathway to a gravel road along the canal from the City Corp Yard to Lely Park, looping back to Linwood via an easement where Hambright Avenue is to be extended. This path would allow children to walk or ride bicycles to school without going out on State Route 32. This action would also give the City the opportunity to apply for state grant programs for pathways.

easement interest transfer between property owner Byron Royce and the City of

Orland. The motion carried by the following voice vote:

City Manager Carr brought forward discussion recommended by the Economic Development Commission to consider a Westside annexation of additional properties on the west side of I-5 into the City for future development and extension of municipal services. The costs for the annexation process may be up to \$20,000, which may be offset by all or partial landowner contributions. City staff recommends a mixed use should be considered to include: industrial, light industrial and commercial. Council agreed this annexation would benefit the City in attracting future development.

City Manager to proceed with preliminary work for a Westside annexation process.

City Manager brought forward for consideration to adopt Resolution No. 2015-24 endorsing a League-supported effort to promote passage of SB 16 for additional funding for street and highway infrastructure funding. This would result in an approximate \$100,000 increase in street maintenance revenue for Orland. Staff has recommended sending a letter in support of this effort.
