ADMINISTRATIVE BUSINESS

A. Recreation Department Annual Review – Joe Fenske, Recreation Director

Recreation Director Fenske gave a power point presentation on the Recreation Department's annual review. Some of the highlights include: Capital Improvement projects completed in 2019 – Linwood Park and Playground and phase 1 of the Orland Recreation Trail (70% complete). Pickleball is a new sport that has been well received this year. Mr. Fenske advised as of July 1, 2019 there is \$405K in the Development Impact Fee fund. The Parks and Recreation Commission has capital improvement plans for Lely softball field and sand volleyball courts. The Recreation Commission plan to discuss future capital improvements in January

2020. Those improvements include the Pump Track, Recreation expansion and softball lights at Lely Park. Mr. Fenske advised the various community partnerships with the Orland Unified School District, Orland Little League, Orland Otters, etc. are very important and benefit the Orland community. Mr. Fenske highlighted the various children, adult and senior recreation programs that are offered throughout the year. A new low impact senior exercise program will be coming soon. Mr. Fenske stated the pool was highly utilized with programs and swim lessons. Vice Mayor Roundy requested future discussion on a heated pool. Another splash pad may be considered near the pool. City Council thanked Mr. Fenske for the great job he continues to do with the Recreation Department.

B. Library Department Annual Review – Jody Meza, Library Director

Library Director Meza gave a power point presentation on library activities this past year. Ms. Meza stated the library has received over \$16k in generous community donations this past year as well as many hours in volunteer time. The various children's programs remain very popular at the library, as well as the annual "Wild Things" animal show and "Magic" show; attendance to children's programs increased significantly. Ms. Meza advised Friends of the Library is a very supportive group which has raised over \$3,000 and has volunteered many hours. The library has received \$31,733 in grants which has been helpful in new Zip books, staff training, ag education and special workshops. There are currently 10,623 library card holders (County 45%, City 49%, Non-resident 6%). A total of 37,132 items were checked out last year. Ms. Meza advised the addition of Saturday hours has been very successful. The library participated in many events: Glenn Stem Expo, Exploratory Career Day, Queen Bee Festival, etc. Ms. Meza thanked those groups they partner and collaborate with throughout the year. Council appreciated all of Ms. Meza's outstanding efforts with the library.

C. Request to adopt Resolution supporting the Reducing Crime and Keeping California Safe Act of 2020 -Joe Vlach, Police Chief

Chief Vlach gave a report requesting adoption of a resolution supporting the Reducing Crime and Keeping California Safe Act of 2020. This is a statewide ballot initiative that will be presented to voters on November 3, 2020. Chief Vlach stated the initiative strikes a good balance as it provides more accountability for criminal behavior.
