ADMINISTRATIVE BUSINESS

A. Update and discuss water system and shop well location - Ken Skillman, City Engineer

City Engineer Skillman gave an update on ongoing water and sewer projects that were included with the capital improvement plan that was implemented in 2015, as well as the scheduled rate increases which supported the plan. Mr. Skillman advised the City shop well was recently shut down (per State regulations) due to coliform contamination, so the City is currently in the planning process to finding an adequate location for a new well. City staff is seeking grants and no-interest financing to help fund the project and help ease rate increases; however, revenue from customers is required in funding system operations, maintenance and improvements. Current projects are on track with the 10-year plan and rates are in line with expected costs. Council advised to keep citizens informed and educated on ongoing and future projects.

B. Surplus items for auction – Ed Vonasek, Public Works Director

Public Works director presented a list of old and unused items for surplus auction to be removed from the Public Works Corporation Yard. The Public Works and Safety Commission agreed with the proposal at their November meeting. City Council discussed and agreed the \$1,500 reserve for Item #21, International Van Pelt Ladder truck, is not necessary as items need to be liquidated. Mr. Vonasek stated the City will receive sealed bids for the auction items. Notices advertising the auction will be posted on the City website, City Hall, Library and social media.
