#### **ADMINISTRATIVE BUSINESS**

City Manager Carr presented the second and final reading of the Modoc Street Annexation #2015-01 adopting Ordinance No. 2015-07 to annex a portion of Modoc Street and adjacent properties into the City. Prezoning Assessor Parcel Numbers 046-080-006, 046-080-007, 046-080-008, 046-080-009, and 046-080-010 to the R-1 (Single-Family Residential) Zoning District.

Councilmember Paschall moved, seconded by Councilmember Edwards to approve the second reading of Ordinance No. 2015-07 to annex a portion of Modoc Street and adjacent properties into the City. Prezoning Assessor Parcel Numbers 046-080-006, 046-080-007, 046-080-008, 046-080-009, and 046-080-010 to the R-1 (Single-Family Residential) Zoning District. The motion carried by the following voice vote:

NOES: None ABSENT: None ABSTAIN: None City Manager Carr brought forward for discussion and consideration of a public safety tax. Mr. Carr advised the City has been challenged in meeting the needs and requests of the Orland Volunteer Fire Department (OVFD) for replacement of equipment, while also maintaining police services. The OVFD also identified the need to plan for a paid chief position in the future. Mr. Carr stated property taxes and sales taxes are considered most viable options; property tax considered the most stable and consistent; whereas, sales tax may be more difficult to predict. Byron Denton felt we should have a parcel tax. Gary Campbell, R & R Car Sales, advised he does not support a sales tax hike; as it would hinder business in Orland. Brittney Hibdon, Hibdon Motors, agreed with Mr. Campbell's statement. Council discussed the possibility of increasing the City's Hotel User Tax (TOT). Council also discussed if the tax should be specific to fire and/or police or a joint tax for public safety. It was noted a parcel tax (special tax) would require a 2/3 vote, although Council can allocate the funds at their discretion. City Manager Carr clarified the Orland Volunteer Fire Department operational fund has always been funded at some level, however, there have been years when it was not possible to allocate monies to the equipment reserve fund. Council directed staff to continue research and consider in the near future.

City Attorney Einhorn brought forward for discussion and consideration of marijuana cultivation. The City currently has a limited marijuana cultivation measure in place; no medical marijuana cultivation permit process is required. The State enacted a cultivation licensing program that would impose the state licensing program on local jurisdictions that do not fully ban cultivation or have a permit process. Council discussed and upon consensus agreed the City should fully ban cultivation of marijuana in the City limits. Council directed staff to bring forward an ordinance, prohibiting cultivation of marijuana in the City limits of Orland.

City Manager Carr brought forward for discussion and consideration of medical marijuana delivery regulation. The State is setting up a dual licensing system under a State license to cultivate or sell marijuana. The Council has expressed an interest in exploring some regulation of delivery. Staff and Mayor Roundy and Councilmember Gee advised they made a visit to a well-run medical marijuana dispensary in Shasta Lake City and learned additional information on the operation of a dispensary. Councilmember Paschall felt that if cultivation is prohibited, the City has an obligation to provide some way for people to gain legal access to medical marijuana. Chief of Police Tolle advised he does not recommend a medical marijuana dispensary in the City limits. Council agreed for staff to continue to investigate possible regulation and taxation of medical marijuana delivery.
