#### **ORAL AND WRITTEN COMMUNICATIONS**

### **Citizen Comments:**

Jody Samons, Glenn County Community Development Director, requested a correction to the City Council minutes of January 22, 2019. Ms. Samons stated manufacturing has been a major focus with the County. We have been able to bring \$18.4 million to projects and businesses, made up of direct cash payments, incentives or tax credits to the businesses here.

Ms. Samons mentioned an upcoming workshop will be held tomorrow evening at 5:30 p.m. on the "7 Simple Steps to Start Your Own Business". A pop-up photo opportunity to market local products will be made available at no charge on February 7<sup>th</sup> at Glenn Success Square.

Byron Denton, 127 Tanner Way, attended the Art show; stated it is quite an asset to our town. Mr. Denton thanked the Orland Volunteer Fire Department (OVFD) for the excellent spaghetti feed.

Mr. Denton asked if there was additional information or action regarding the property across the street from City Hall which had an appraisal done. Mayor Roundy advised no information at this time.

Marvin Forbes, 117 E. Yolo Street, stated the water at his property has an odor and does not taste good. He stated the cause may be the aged galvanized pipes, however, he would still like Public Works to check it out. Mr. Forbes mentioned he had spoken to the PW Director previously and he stated it may not be enough chlorine.

Mayor Roundy advised the OVFD requested the agenda item concerning the paid Fire Chief be presented earlier in the meeting as a prior training commitment is scheduled.

## **ADMINISTRATIVE BUSINESS**

Consider proposed draft agreement for paid Fire Chief – Pete Carr, City Manager

Mr. Carr brought forward as requested by the OVFD volunteers, a proposed draft agreement to partner with the Orland Rural Fire Protection District Board (Rural Board) and OVFD in establishing a full-time paid fire chief position. The City is now proposing a service fee of \$159 per call outside the city limits, regardless if it's a medical aid, fire, large incident or small; reevaluating service fee each year moving forward. The Rural Board will meet on February 12, 2019 where the proposed agreement will be presented. The OVFD volunteers endorse this concept. Mr. Carr provided a copy of the draft job description with a minor addition to licenses and certifications. Council discussed whether the agreement should specify compensation for the Deputy Fire Chief in the case the Fire Chief was suspended. Councilmember Paschall stated it did not address what kind of compensation would be given to those on call for the Fire Chief. City Attorney Einhorn stated it would be best to address compensation on a case by case basis. Brandon Livingston, Chief Committee Chairman, stated the question on what kind of compensation for Assistant or Deputy Fire Chief, will depend on volunteer availability (may change from day to day). Mayor Roundy stated the Council is ready to move forward on the issue.

## Presentation:

Presentation regarding Bee City and Honey Bee Discovery Center (HBDC) - Terrie Barr

Terrie Barr, member of the Honey Bee Discovery Center, presented to City Council an update on Bee City and Honey Bee Discovery Center activities. The founding committee of the Honey Bee Discovery Center had an initial plan of building a Discovery Center at Patrick Ranch in Durham. However, plans have now changed, the committee is now dedicated to locating the Honey Bee Discovery Museum in Orland. The purchase of the former Farm Bureau building on the SW corner of Walker and Fifth Street is currently going through escrow and would begin to house a portion of the museum and to offer office space for the Chamber of Commerce. With the City's recent purchase of property west of this location, the committee hopes to include a HBDC complex along with the City's proposed community center. Ms. Barr stated once escrow closes, the hope is to begin renovations on the building and be completed in time for the Queen Bee Capital street festival on June 22<sup>nd</sup>. Ms. Barr added she has been hired to dedicate her efforts to fundraising efforts, grant writing, and marketing for the new HBDC complex. A complete proposal of the HBDC complex will be brought forward to Council at a later date.
