#### A. <u>Citizen Comments</u>:

Jody Samons, Community Development Director, thanked the City of Orland for their cooperation and partnership with the county in economic development. A report will be coming out highlighting accomplishments and a guide for the future. Ms. Samons stated manufacturing has been a major focus with the County. We have been able to bring \$18.4 million to projects and businesses, made up of direct cash payments, incentives or tax credits to the businesses here.

# C. <u>Department Presentation</u>:

Police Department Annual Review – J.C. Tolle, Chief of Police

Chief Tolle gave an overview of activities in the Police Department in 2018. Two new police officers were added to the department this past year: Katherine Lowery and Edgar Andrade; with another cadet in the academy. Chief Tolle advised calls were down a little this past year in comparison to 2017 and arrests had increased a bit (458), compared to last year (415); 33 were DUI related and 1/3 were a combination of drugs and alcohol. The #1 moving violation is stop signs, #2 is speeding, and #3 is cell phone use. Chief Tolle stated three (3) officers were sent for mutual aid to assist with the Camp Fire. There are currently 17 VIP members which logged approximately 2337 service hours. Chief Tolle highlighted his personnel plan in no specific order: 2 new additional officers, 1 Community Service Officer, a Lieutenant or additional Sergeant position, Full-time Narcotics Task Force officer and a full-time School Resource Officer. Chief Tolle noted that POST will be coming in February to perform a management audit on the department and he will share that report at a later date. Chief Tolle advised a new Public Safety Facility combined with the Fire Department is the number priority plan for the department's wish list for the future.

# Mid-Year budget review - Pete Carr, City Manager

Mr. Carr provided Council with a summary of budget revenues and expenditures midway through the fiscal year. Revenue is currently at 2% over budget and expenditures are about 3% under budget. Mr. Carr stated the not yet received property taxes has been estimated at one half of what was budgeted, and the City has already received 53% of the sales tax budget (1.8k). Mr. Carr noted that the Building Department revenue is ahead of pace but is uncertain whether additional builders will pull permits later. The Police Department expenditures are running 2% less than budget. The net of revenue versus expenditures at mid-year is positive, however, not enough of a cushion for mid-year discretionary expenditures. Mr. Carr noted any net gain will help restore the General Fund Reserve balance. Staff discussed higher than budget utilities expenses for water despite solar on all the wells, except for the Eva Drive well. Budget forecasted 73% reduction in electric usage, mid-year looks like 37% reduction. The shop well which was shut down recently did have solar; consequently, the Eva Drive well has been running frequently. An estimate for solar from Alternative Energy Systems was recently requested for the Eva Drive well. Council also advised staff to look deeper into fleet maintenance costs allocations.
