#### ADMINISTRATIVE BUSINESS

City Manager Carr brought forward discussion on irrigation canals in Orland due to a recent tragic event which occurred on Fifth Street and Roosevelt Ave. portion of Lateral 40. Mr. Carr stated some of the canals predate the City and the U.S. Orland project; however, they still remain a vital part of today's regional ag industry. Betty Skala, 1308 Pine Street, advised the ditches should be reevaluated and put underground to make it safe for children of all ages. Councilmember Edwards expressed sympathy on behalf of the Council to the family that lost their child and praised the lifeguards for their diligent efforts to save the child. Mayor Hoffman advised the City is limited on what they can do; however, conditions can be applied in new subdivisions to make ditches less accessible, as far as undergrounding or fencing. Mayor Hoffman stated the City and the Orland Unit Water Users Association (OWUA) should partner together and look at different possibilities to solve the issue.

City Manager Carr brought forward discussion on the odor issue in Orland. Residents have been complaining for some time about the foul odors coming from south of town. These ongoing complaints have been referred to the Air Pollution Control District. Wilbur-Ellis operates an open-air dehydrating facility at the airport and concerns were addressed in the 2013-2014 Glenn County Grand Jury Report regarding an odor coming from the silage storage or the olive brine ponds.

John Viegas, Glenn County Board of Supervisor, advised Council he has been in contact with Wilbur-Ellis and they are willing to meet with the public on the matter. The County has had a contract with Wilbur-Ellis for over 20 years and they employ 5 people. The current contract with the County is up for renewal on

September 30<sup>th</sup>, 2017. Mr. Viegas advised complaints are taken seriously and wants to look at all options to resolve the issue and find the origin of the problem.

Troy stated the odor is a rotten smell. Kim King, 65 E. Colusa St., stated the County and City need a plan to solve this problem; however, it has been a constant problem during the hot weather. John McDermott, 525 First St, stated the Glenn County HRA building was evacuated at least once due to a pungent smell, which he stated emanated from the brine ponds. Heather stated the Wilbur-Ellis smell has become unbearable and has caused her sore throats. She stated she didn't know if the product could be causing more fruit flies.

Council directed the City Manager to report back on whether there is an odor issue coming from the brine/sewer ponds and directed staff to draft a letter to the Glenn County Board of Supervisors and Air Pollution Control regarding the odors from the Wilbur-Ellis silage storage at the airport and what could be mitigated.

City Attorney Einhorn brought forward discussion regarding the City Treasurer vacancy. The City Treasurer position was vacated by Pamela Otterson effective July 5, 2017and Council needs to determine whether to appoint or have a special election to fill the vacancy within 60 days. An appointee must be a City resident and registered voter of Orland. Mr. Einhorn stated an appointee would serve until the next general election in November 2018. It was noted that Council may decide to present to the voters at the next General election, the question on whether the position of City Treasurer and City Clerk should be changed from elected to appointed. Council discussed staff's recommendation of an internal appointment and the option of advertising for an outside appointment. Councilmember Gee advised someone with fiscal experience should be considered. Councilmember Edwards felt the appointment should be open to others that may desire to apply. Vice Mayor Roundy stated an appointment from within or outside staff is fine. Councilmember Paschall recommended the City Manager appoint from within staff, with Mayor Hoffman in agreement. Mr. Carr stated the City Treasurer is responsible for reporting the long term fiscal health of the City and would meet with the City's Investment Advisory Committee to discuss future investments.

Manager to appoint someone from within staff to fill vacant City Treasurer position. The
