Discussion occurred regarding the City Attorney contract. City Manager advised the proposed contract on the agenda states an annual compensation of \$48,000, with additional work at the rate of \$110/hour; and also providing the City with a credit up to 35 billable hours per year. However, a more recent discussion with Mr. Einhorn resulted in an understanding for a proposed \$44,000 retainer, additional work at \$110/hour and no provision for credit of billable hours.

PUBLIC HEARING

ADMINISTRATIVE COMMUNICATIONS

City Manager:

City Manager Carr requested Council to consider authorizing the City to participate in the Figtree Property Assessed Clean Energy (PACE) Program in 2014. The Economic Development Commission voted unanimously to recommend the City Council to approve the proposed program. It was noted there were significant opportunities for owners of commercial property to benefit from another method to finance energy saving capital improvements, in addition to other financing, rebate and tax incentive programs. Mr. Carr gave a summary of the necessary steps to allow property owners in the City of Orland to participate in the program. Councilmember Roundy questioned whether the City could provide an open PACE marketplace. Council directed staff to look into whether an open marketplace would be feasible and to bring information back at the next regularly scheduled Council meeting.

City Manager Carr brought forward the request to approve and execute Dispatch and Animal Control Services Agreements with the County of Glenn at specified rates. An agreement was reached in May to continue to contract services at the current service level and at the new rate of \$93,000 for dispatch and \$55,000 for animal control, for a one-year agreement. Council advised it was a fair proposal.

dispatch and animal control service contract extensions and authorize the City Manager to execute the agreements as proposed. Motion carried by the following

City Manager Carr presented to Council for review and to consider the FY 2014-2015 Project Objectives. Council discussed and recommended a fleet management plan for Public Works. Mr. Carr stated Project Objectives will be reviewed again during mid-year. Mr. Carr advised he will bring forward a new draft with new recommendations at the next regularly scheduled Council meeting.

City Manager Carr requested Council to consider adopting the Final Budget for FY 2014-2015. Revenues are anticipated to increase by 3.8% and expenditures are up by 2.22% overall. Health insurance costs will not increase as much as first indicated. The budget shows a near balance.
