ADMINISTRATIVE COMMUNICATIONS

## Assistant City Manager/City Clerk:

Assistant City Manager/City Clerk Crook requested Council to consider publishing a notice to fill one or two unexpired terms on the Economic Development Commission. EDC Commissioner Sarah Leydon sent a letter requesting resignation from the commission; her term expires December 31, 2013. EDC Commissioner Edgar Valenzuela indicated to staff he is no longer able to serve on the commission as well; his term ends December 31, 2014.

Councilmember Paschall moved, seconded by Vice Mayor Hoffman to accept the resignation of Ms. Leydon and Mr. Valenzuela and publish a notice for both vacancies on the EDC Commission. Motion carried with no abstentions.

Ms. Crook requested Council to consider invitation from Orland Pride to participate in Fourth of July parade (no entry fee). Council agreed previously to participate in the annual Fourth of July parade.

#### City Manager:

City Manager Carr presented to Council the proposed Five-Year Plan, with amendments, as suggested by Council at the June 3<sup>rd</sup> meeting. Council discussed adding language to include establishing a reserve fund formula for the Fire Department and establishing an equipment reserve fund for the parks(i.e.replace pool pump, picnic tables, field lights).

Vice Mayor Hoffman moved, seconded by Councilmember Edwards to approve the Five-Year plan as presented with additional amendments as mentioned. Motion carried with no abstentions.

Mr. Carr brought forward the proposed FY 2013-2014 budget for adoption. Mr. Carr advised the General Fund is barely balanced with several positions remaining unfilled at this time. It was noted medical insurance premium cost will only increase by 1.4%, a significant reduction from what was originally projected at 12%. Workers Compensation costs also declined \$17,000 from its current level. Other changes which were discussed at the last budget session were implemented in the proposed final draft.

Councilmember Edwards moved, seconded by Vice Mayor Hoffman to approve the FY 2013-2014 Budget as presented and direct staff to publish. Motion carried with no abstentions.

Mr. Carr brought forward the completed Project Objectives list for the last fiscal year and introduced new Project Objectives for 2013-2014 to be considered by Council. Projects for the upcoming year were discussed and Council requested more time to review the list. It was noted users are visiting the City website more frequently for information. Council discussed possibilities of posting City accomplishments and requesting public input on matters.
