2011 General Plan and Housing Element Annual Progress Report:

Interim City Manager Wingard request Council discussion and guidance on the library expansion Interim City Manager Wingard advised there is interest in improving the facility and provide space for the citizens of Orland. Expansion is proposed for the south side of the building; the bathrooms would require meeting ADA requirements. Staff advised impact fees and funds the Friends of the Library have set aside could be used for the expansion. Council advised this is a great opportunity but to also move carefully and determine what we can afford. Library Director advised the library is in need of an expansion. Gene Russell, President of the Friends of the Library, advised there is \$80,000 set aside for building funds for the library.
