PUBLIC HEARINGS

 Modoc Street Annexation: Annx. #2015-01: A city-initiated proposal to annex and establish City zoning (pre-zoning) on five (5) existing parcels into the City of Orland with no changes in land use. These parcels are located at the northerly end of Modoc Street and Butte Street, south of the USID Lateral 40 canal and are further described as Glenn County Assessor's Parcel Numbers 046-080-006, 046-080-007, 046-080-008, 046-080-009, and 046-080-010. All five of the subject parcels are located within the Glenn LAFCO adopted Sphere of Influence of the City and all of the parcels are designated with the *R-L (Low-Density Residential)* land use designation on the City of Orland Land Use Diagram. The R-L land use designation allows for the development of a maximum of 6 dwelling units per acre. All of the developable parcels (4 of 5) have existing single-family land uses established on them and are consistent with the requirements of the proposed City of Orland *R-1, One Family Residential* zoning district relative to land use and lot size.

City Planner Friend brought forward a first reading of the proposed Modoc Street Annexation. The annexation would include five (5) existing parcels of land into the City with no proposed changes in land use. All four of the developed parcels currently receive water from the Orland Public Water System and two of the four parcels receive wastewater service from the City. The Planning Commission unanimously recommended to the City Council the approval of the application. The second reading will be brought forward at the next regularly scheduled Council meeting.

City Planner Friend discussed the draft letter response regarding the KVB Draft Environmental Impact Review. The City is supportive of the project, but is concerned about the lack of attention to transportation impacts to the City of Orland, after persistent efforts to address this issue.

City Manager Carr has requested Council to adopt Resolution No. 2015-35 to amend utility billing and related fees. Council discussed at the last Council meeting to increase the true cost of administrative and field work to process late payment and shutoff and reconnections services. Mr. Carr stated a late payment notice would increase from \$10 to \$25; shut off/disconnection fee would increase from \$25 to \$50, with an afterhours total cost of \$125. The City's tampering fee would remain the same at \$150.

City Manager Carr brought forward for discussion the Public Arts fee related to the Pilot Travel Center project. Mr. Carr stated the Arts fee is closely related to the development impact fee but is based on construction project valuation rather than on construction square footage. The Pilot Travel Center

project Arts fee was determined to be \$20,000, based on the valuation of the project. Police Impact fees were \$2,143 and Fire \$4,073. The developer voiced a concern that the Arts fee was high, in comparison to other fees. Nevertheless, the developer paid all fees in full. Council discussed whether the calculation of the Arts fee should be reexamined. City Attorney Einhorn suggested the ordinance could be amended to impose a cap on the Arts fee. Mayor Roundy stated the Arts Commission fee was reduced in 2013 and would rather not have to give back what has already been collected on the project. However, he does understand the concern of the higher fee. Mr. Einhorn advised Council can reduce or waive fees. Councilmember Edwards suggested reducing the Arts fee by 50% for the Pilot project. Council discussed and agreed the fee should be reduced. It was also suggested, perhaps Pilot may want to consider making a donation towards the new art sculpture project.

Action: Councilmember Edwards moved, seconded by Councilmember Paschall to approve reducing the Arts Fee by 50% (\$10,000) for the Pilot project; also send a letter of suggestion regarding consideration of art donation towards the sculpture project. The motion carried by the following voice vote:
