PUBLIC HEARING

Zoning Code Text Amendment ZCA 2012-01: A proposed amendment to Title 17, Zoning, of the Orland Municipal Code to allow "food trucks" and "catering trucks" in the C-1, C-2, C-H, and M-L zoning districts upon issuance of an administrative use permit. This amendment would entail minor revisions to Chapters 17.08, 17.36, 17.40, 17.44, and 17.48.

City Planner Friend gave a brief report. Public Hearing opened 7:42 pm. No comments were received. Public Hearing closed at 7:43 pm.

After Council discussion, Vice Mayor Gee moved, seconded by Councilor Paschall to approve first reading of ordinance to amend Title 17, Zoning, of the Orland Municipal Code to allow "food trucks" and "catering trucks" in the C-1, C-2, C-H, and M-I zoning districts upon issuance of an administrative use permit. Motion carried with no abstentions.

ADMINISTRATIVE COMMUNICATIONS

City Librarian:

City Librarian Meza gave an update on Library activities and presented a summary of the 2011-2012 Annual Report. A detailed copy is available at the Library.

Chief of Police:

Chief of Police Tolle brought forward to Council three proposed stop sign recommendations from the Public Safety Commission.

- 1. Installation of stop signs on Yolo St. at Woodward at the entrance of the Fairgrounds.
- 2. A 4/way stop sign at the intersection of 6th and Tehama Sts. If not feasible, a left turn lane be installed for southbound 6th onto eastbound Tehama St.
- 3. 4/way stop at the intersection of Marin and Chapman Sts, and a 3/way stop sign on South St. at Marin.

Vice-Mayor Gee moved, seconded by Councilor Paschall to approve and install stop signs at the above listed intersections. Motion carried with no abstentions

City Manager:

City Manager Carr discussed utility billing practices, accounts receivable and processes for collection of unpaid bills. A draft code was presented to authorize municipal utility property liens. Council discussed online bill pay and habitual delinquent accounts. A proposed ordinance will be presented at a future meeting.

City Manager Carr gave an update on capital improvements projects. Request for proposals are being issued on the library expansion project. The Parks Commission met this evening and

will bring forward a list of priority improvement projects such as: upgrades to swimming pool, new skate park etc.

City Manager Carr requests Council discussion and consideration of restoration of 2006 City Council's monthly stipend. Council discussed and agreed to not restore stipends at this time.

Mayor Elliott moved to restore Councilmember stipends at the beginning of the next calendar year. Motion died due to lack of a second.
