ADMINISTRATIVE BUSINESS

A. Update on real estate purchase – Pete Carr, City Manager

City Manager Carr gave an update on the City's purchase of the railroad property (Sixth & Colusa Street) that is currently going through escrow. This property is intended for a future public safety facility. A Phase I soil analysis has been completed, however, there is justification for further analysis of a Phase II soil inspection which will not likely be completed before the contract close-of-escrow date of November 10, 2018. Mr. Carr recommended to Council to extend the close-of- escrow date. Mr. Carr also noted the second property the City is currently in contract with, known as the McKinney property, located off Walker Street between Fifth Street and the railroad tracks, is currently going through a Phase I soil analysis. Council discussion occurred.

B. Consider Tehama Street Design contract – Ken Skillman, City Engineer

City Engineer Skillman stated the Tehama Street Rehabilitation and Road Improvement Project is currently planned for reconstruction of the road, sidewalks, bike lanes and other improvements to Tehama Street between Woodward and the railroad tracks at Sixth Street. The City received two proposals for the design consultant contract and recommended awarding Northstar Designing Solutions for the Tehama Street and Road Improvement Project in the amount of \$94,182.25. The anticipated budgetary Regional Transportation Improvement Program (RTIP) and State Transportation Improvement Program (STIP) program funding for the construction phase is \$750,000 which will be applied for once the design is complete and project goes out to bid to contractors. Council discussed and received public input.

C. Request purchase of backup cloud storage system for OPD data files – J.C. Tolle, Chief of Police

Chief of Police Tolle brought forward request to purchase a backup server that will replicate OPD data to the cloud using the Barracuda 490 system to resolve the failed backup system. Measure A funds will pay the initial cost to purchase and an annual fee of \$5,000, for a total cost of approximately \$13,000. Council discussion occurred.
