City Manager Carr requested Council to consider the Sustainable Groundwater Management Act cost share proposal. The Groundwater Sustainability Agencies (GSA's) and the County have been meeting regularly to draft common principles; explore governance options; identify priorities, tasks and projected costs which are unknown. The County is proposing all the GSA agencies, including the County, to engage the consulting firm, Davids Engineering, to provide technical support for SGMA related tasks and to share the cost equally among eligible GSA's. Mr. Carr advised anticipated cost is approximately \$2200 per agency. Council discussed and concurred the City needs to proceed with the County's proposal; otherwise costs would be prohibitive for the City to proceed on their own.
