**MINUTES OF THE ORLAND CITY COUNCIL**  
**REGULAR MEETING HELD SEPTEMBER 20, 2022**

**CALL TO ORDER**

Meeting called to order by Mayor Hoffman at 6:30 p.m.

Meeting opened with Pledge of Allegiance led by Councilmember Chris Dobbs.

**ROLL CALL**

**ORAL AND WRITTEN COMMUNICATIONS**

**PUBLIC COMMENTS:**

Ryan Everest & Russell Pierce, Orland Little League representatives, presented a check for \$1000.00 to show appreciation of the partnership between Orland Little League and the City of Orland. Mr. Everest thanked the City for its continued relationship over the last few years.

Action: Councilmember Dobbs moved, Vice Mayor Tolley seconded, to approve items A-E on the consent calendar. The motion carried by a voice vote 5-0.

**PRESENTATION**

Amy Travis, Deputy Director, Office of Emergency Services for Glenn County Sheriff's Office presented a PowerPoint presentation for a new project that was rolled out on September 20<sup>th</sup>, 2022. Ms. Travis shared that the County has partnered with fire, law, OES and the County Planning Department to establish pre-defined evacuation zones for Glenn County. Ms. Travis stated that there will be 165 evacuation zones that are organized into 20 community areas.

Ms. Travis shared the website and direct link, and walked the Council step by step through the site to give a quick demo of how to use the map and to assist residents to quickly find their evacuation zones [www.countyofglenn.net/Evacuations](http://www.countyofglenn.net/Evacuations). Ms. Travis stated that all this information has been uploaded to

the CodeRED emergency system. Ms. Travis recommended all residents sign up for the CodeRED alerts to get the information sent directly to them in the case of an emergency. Ms. Travis also recommended residents to go to the map and find their evacuation zones for home, work, and their children's schools to be prepared for any future emergencies.

Councilmembers shared questions about publication of this information and asked City Staff to use water bill to alert Orland residents about the evacuation zones.

## **ADMINISTRATIVE BUSINESS**

### **A. SKATE PARK**

Vice Mayor Jeffrey Tolley announced that he has decided to step aside as the leader of the skatepark committee but will remain an advocate for the skatepark project.

Recreation Director Joe Fenske provided an update to Council on the July 19<sup>th</sup> discussion regarding sending a survey to City residents; at that meeting Council asked the Orland Skatepark Committee to provide a cost estimate for the project, and then Council would consider publishing a survey to the community seeking interest in the project. Mr. Fenske explained that he had been working with City staff and the skatepark committee to come up with a couple of estimates; for a 20,000 sq ft skatepark with a bowl feature the estimate would be around \$1.5-\$2.0 million and for a 10,000 sq ft skatepark with raised steel ramps and concrete features the estimate would be around \$600,000-\$1,000,000.

Mr. Fenske provided cost estimates and options for Council to decide how the survey should be sent out and shared an example of what the survey could look like.

Council asked questions about the survey and discussed ideas regarding the look of the surveys. Council was unanimous on going through with sending out the survey with the September City water bills.

### **B. VERBAL UPDATE ON DROUGHT CONDITIONS AND WATER SUPPLY PROJECT**

City Manager Pete Carr provided an update on reported dry wells, stating an additional 2 wells have been reported since the last City Council meeting. Currently the total of dry wells being reported this year is 78. The total number of wells affected for this drought is now listed at 412, with 270 reported as dry.

Mr. Carr reminded Council that the Department of Water Resources (DWR) project is connecting around 180 county residents to City services. Mr. Carr shared with Council that connections within City limits are currently in progress, Public Work Department is out digging trenches and preparing lines. Mr. Carr stated that City and Department of Water Resources (DWR) Engineers are currently on track and working daily on planning, design work and permitting.

Mr. Carr stated that the City's municipal well services remain stable and continue to produce good drinking water. Mr. Carr shared that the deeper City wells are beginning to show signs of improvement since last year.

Mr. Carr reminded Council that the City is still in stage 2 of the drought contingency plan and the City is still asking residents to reduce water use as well as assisting residents in finding water leaks around their homes when needed.

### **C. DEVELOPMENT REIMBURSEMENT AGREEMENT FOR NEWVILLE ROAD AND FREEWAY OFFRAMP**

Mr. Carr reminded Council that in May 2022 the City came to an agreement with the developer to reimburse the developer a portion of the expenditures they are having to make in constructing the signalized intersection at Commerce and Newville. Mr. Carr stated that the agreement was structured to work with the developer such that the City would make a contribution and additional development in that area in future years would allow for reimbursement to the developer due to traffic study requirement of a signalized intersection at Commerce and Newville.

Mr. Carr shared that Caltrans is now requiring the developer to widen the southbound I-5 offramp as a condition for approval of the project. The one lane would turn into two lanes all the way off the ramp. Mr. Carr stated that City staff would like to see a third lane headed west on Newville (a right turn only, left turn only and thru-lane) to help traffic flow and economic development.

Mr. Carr stated the City will need a development reimbursement agreement to determine an amount for the City, the current developer, and any future development. Mr. Carr asked Council for two members who would join City Staff to create an ad hoc committee to develop a proposed development reimbursement; Councilmembers Bruce Roundy and Billy Irvin volunteered.

**DURING A PROCLAIMED STATE OF EMERGENCY**

WHEREAS, the Ralph M. Brown Act requires that all meetings of a legislative body of a local agency be open and public and that any person may attend and participate in such meetings;

WHEREAS, the Brown Act allows for legislative bodies to hold meetings by teleconference, but imposes specific requirements for doing so;

WHEREAS, on March 17, 2020, in order to address the need for public meetings during the present public health emergency, Governor Newsom issued Executive Order No. N-29-20, suspending the Act's teleconferencing requirements; and

WHEREAS, on June 11, 2021, Governor Newsom issued Executive Order No. N-8-21, continuing the suspension of the Brown Act's teleconferencing requirements through September 30, 2021; and

WHEREAS, these Executive Orders allowed legislative bodies to meet virtually as long as certain notice and accessibility requirements were met; and

WHEREAS, the State Legislature amended the Brown Act through Assembly Bill No. 361 (AB 361) on September 16, 2021; and

WHEREAS, AB 361 amended the Brown Act so that a local agency may use teleconferencing without complying with the regular teleconferencing requirements of the Act, where the legislative body holds a meeting during a proclaimed state of emergency and makes certain findings; and

WHEREAS, Government Code section 54953 requires that the legislative body make additional findings every 30 days in order to continue such teleconferencing.

NOW THEREFORE, the City of Orland hereby finds, determines, declares, orders, and resolves as follows:

1. That the foregoing recitals are true and correct and incorporates them by this reference.
2. The City Council of the City of Orland finds, by a majority vote, the following:
  - a. That there exists a proclaimed state of emergency; and
  - b. State or local officials have imposed or recommended measures to promote social distancing.



3. The City Council and any of its committees, joint committees, ad hoc groups, and staff is authorized to take all steps and perform all actions necessary to execute and implement this Resolution in compliance with Government Code section 54953.

4. This Resolution shall take effect October 4, 2022 and shall remain in effect for thirty (30) days thereafter (until November 1, 2022), provided the conditions set forth in Section 2 remain.

---

**BACKGROUND:** The City Council annually, as part of the fiscal budget process, sets forth objectives for the City for the coming fiscal year. Major project objectives are summarized on one page in a 4-quadrant prioritization format recognizing relative urgency and importance amongst the projects. The projects are all in addition to normal ongoing operations within departments, and there are many other "minor" improvements underway in various departments not shown on this report. Staffing resources are a significant limitation for most projects.

**DISCUSSION:** For the July-September report, highlights include:

- A. The Orland Emergency Groundwater Supply Project in partnership with the State and County is absorbing an overwhelming amount of resources – especially Engineering and Public Works but also Administration and Planning. The scope of the project is expanding as we work on it. The project is too complex to break out into its many "moving parts" on this report, but overall it is on track with its objectives and timeline. Soil issues and federal environmental permitting present a risk to the target timing for Phase 2.
- B. The Newville Road at 9<sup>th</sup> Street traffic safety design will start with an RFP for an analysis by a traffic study consultant; we have identified available funding for this study through the Glenn County Transportation Commission.
- C. Reconstruction of M½ is on track to start in the second half of 2023. Canal crossing plans and environmental permits are currently significant outstanding tasks in progress.
- D. With State Library grant funding just recently becoming defined, library and other facility improvements can now move forward.
- E. Some Lely ballfields lights were upgraded last fiscal year, and the balance are planned for this coming winter (post soccer / pre-softball).
- F. Work is now underway for construction of the pump track at Lely Park while pickleball and tennis court projects are being completed at Vinsonhaler Park.

Additional major projects not on the City list but requiring and receiving intensive Staff support include development of multi-family housing complexes, single family housing subdivisions, Maverik and McDonalds, and other proposed developments.

#### **BACKGROUND**

City fees are set by City Council after cost studies indicate actual or average estimated costs for services. Fees are set at rates intended to generally cover City cost, or less, and are published to make fees predictable for prospective users of City services.

Waiving fees is an option within the purview of City Council, not City Staff.

#### **DISCUSSION**

Valerie Johnson, a Glenn County resident with Hidden Treasures Sanctuary & Rescue, a 501(c)3 tax-exempt non-profit organization, is making application for a conditional use permit (CUP). The CUP is a necessary permit to conduct the requested activity at the stated location – 33 E. Walker Street – which is zoned C-2 Commercial. The CUP permit application fee is \$2,819. The CUP application will be heard at the Planning Commission.

#### **BACKGROUND**

City fees are set by City Council after cost studies indicate actual or average estimated costs for services. Fees are set at rates intended to generally cover City cost, or less, and are published to make fees predictable for prospective users of City services.

In the case of development impact fees (DIF), the fees are set by the City Council after exhaustive analysis of the estimated impact of current development on the cost of forecasted capital investment requirements for facilities and equipment to meet the expanded service demand. Fees are set at that cost, or below. Waiving and reducing fees on a case-by-case basis is an option within the purview of City Council, not City Staff.

#### **DISCUSSION**

DIF for the 33-unit Habitat for Humanity permanent supportive multi-family housing facility under construction at 827 Newville Road total \$380,308 as shown on the attached worksheet. Habitat for Humanity Yuba/Sutter is requesting City Council consideration of its request to reduce DIF by \$111,888 in this case due to the budget constraints of the project, for which \$268,420 is allocated by HHAP (Homeless Housing, Assistance and Prevention grant program) funding for DIF. The building permit for this project – a separate fee – is \$42,330 and has been paid.

The request is effectively for a 29% DIF fee reduction. Council may wish to consider that Parks fee categories represent 37% of the total at \$142,888. Community & Recreation facilities are 15% at 57,616. The Public Arts Fee is \$11,250; City Code allows for this to be waived for projects like this under OMC 2.18.080 B3-6. Council may also wish to consider the nature of the project and its unique impact.

Action options include:

- A. Approval of a reduction in DIF of the Arts Fee and portions of the Parks Improvement Fee and Community & Recreation Facilities Fee (total \$111,888); or
- B. Approval of a reduction in some other amount (specify % or \$ amount); or
- C. Deny fee reduction request.

**SUBJECT: Fee Reduction Request for 827 Newville Road (Purpose Village)**

Habitat for Humanity Yuba/Sutter ("Habitat") requests a fee reduction in Local Development Impact Fees ("Fees") for the property located at 827 Newville Road in Orland, CA. **The request asks that the Local Development Impact Fees equaling \$380,308 be reduced by \$111,888 to assist in the overall development and success of this project.**

The Dos Rios Continuum of Care provided Habitat with a Homeless Housing, Assistance and Prevention (HHAP) grant worth \$268,420 to satisfy Fees. This funding source has reached its funding limit and is the only repository of funds available for Fees without extracting dollars from other line items of the construction budget.

Due to additional costs (approximately \$1,200,000 from design and construction-related work) from the General Contractor as part of this development effort, Habitat aims to reduce costs in other areas of the project budget. By reducing the Fees due to the City of Orland, Habitat can better address capital expenditures and conserve cash resources from its Restore net revenue for operational expenditures.

Habitat does not normally seek fee reductions but it would be in the overall best interest of the project and all stakeholders if the fee reduction was considered.

2.18.080 - Projects subject to public arts program requirements.

- A. Requirements. Except as provided in subsection B of this section, the requirements of this chapter shall apply to all works of construction and rehabilitation for which a building permit is required, including but not limited to:
1. New commercial and industrial construction;
  2. Remodeling or reconstruction of existing commercial or industrial property;
  3. New residential subdivisions or developments of two or more units, whether by detached single-family residential structures, condominiums, apartments, duplexes, townhouses or other dwelling units being built in the same tract by the same owner or developer;
  4. New individual single-family residential units constructed on a lot located in an existing subdivision whose building permit valuation is over one hundred thousand dollars (\$100,000.00).
- B. Exceptions. The requirements of this chapter shall not apply to the following activities:
1. Public projects undertaken by any agency of the city, the state, county, school district or any other governmental entity;
  2. Remodeling, repair or reconstruction of structures to comply with earthquake seismic safety code standards or which have been damaged by fire, flood, wind, earthquake or other calamity;
  3. Remodeling, repair or reconstruction of residential units;
  4. Nonprofit social service or cultural institution projects;
  5. Low to moderate housing projects as defined by household income Health and Safety Code Section 50093;
  6. Affordable housing developments receiving city, state or federal assistance;
  7. Private educational institutions which provide general education equivalent to the public school system (kindergarten through high school or any part thereof);
  8. Architectural rehabilitation or historical preservation of properties which are designated as historic sites by the city council.

City staff seeks updated discussion on use of Covid-relief grant funds, and action to redirect certain allocations.

**BACKGROUND**

Council has engaged in many conversations and several actions to incrementally allocate American Rescue Plan Act (ARPA) funds with \$270,000 remaining unallocated as of June 7, 2022. Many of the allocated ARPA projects are in progress or complete. One of the items allocated was \$80,000 for a match toward a possible future State Library grant; that grant was recently awarded at \$267,000 with a required minimum match of \$134,000. Planned project work is expected to require \$436,000.

Council also set aside in 2021 a portion of CV2/3 funds for facility improvements with the balance going to a County-Willows partnership to distribute grants to small businesses. These grants funds were in addition to the earlier CV1 grant program for small businesses, SBDA grants for businesses, and the current Glenn County Stabilization Grant Program. Facility improvement allocations were specific to Library, Recreation, and City Hall/Police.

**DISCUSSION**

August 16<sup>th</sup>, Staff reported that it appeared \$68,000 of surplus CV2/3 funds could be repurposed for a community e-gift card program, and this was approved by Council, but we have since learned that certain restrictions require that the \$68,000 be reprogrammed to facility improvements. A resolution will be provided October 18 for this action, which must be completed and filed with the State this month.

The CV2/3 funds previously set aside for facility improvements, combined with the surplus \$68,000, provide more than sufficient grant match for the State Library grant. This frees up \$80,000 from ARPA to more than cover the approved community e-gift card program.

CV2/3 facility improvements planned were originally and remain as follows:

- Library – roof replacement, HVAC, entries with touch-free doors -- \$91,000
- City Hall/OPD – touch-free entries -- \$47,000
- Recreation – touch-free doors -- \$23,000

The surplus \$68,000 in CV2/3 will add to the \$91,000 set aside for Library facility improvements for a total \$169,000 grant match and a total funded project budget of \$436,000.

The Use of ARPA Funds Worksheet, updated June 7 as part of the annual budget, is presented this evening with several suggested adjustments:

- The term "approved" is replaced with "allocated."
- The designation M/A for Measure A is replaced by the designation P/S for Public Safety.
- Item 2B (library) is now zero and can be eliminated.
- Item 6 (infrastructure) is proposed for a description change, recognizing the use of funds could be for both freeway interchanges (Exits 8618 and 619).
- Items 9 (streetscapes) and 16 (parking lot) are proposed for allocation. A plan for specific expenditure of Item 9 has not yet been developed but would be presented to Council prior to expenditure.
- Item 11 (pump track) is changed from blue to red to indicate that the planned project is now in construction.
- Item 17 (3CORE) is added as it was approved by Council in August.
- Item 18 (gift cards) is added in lieu of the \$68,000 original approval for CV2/3 allocation.
- These adjustments would fully allocate all ARPA funds.

(Discussion/Action)

---

City ad hoc committee will request City Council approval of a draft proposed reimbursement agreement with a developer for certain infrastructure improvements.

#### **BACKGROUND**

When Conditions of Approval (COA) of a development project obligate a developer to install infrastructure such as streets and signals, the lead public agency will sometimes enter into an agreement with the developer to accomplish specified improvements and share a portion of the cost. Development reimbursement agreements are separate from land use actions and are under the purview of the City Council. Some of the infrastructure improvements related to development in Orland proposed by Maverik were required COA by the City, some are requested by the City, and some are required COA by Caltrans.

On March 1<sup>st</sup> of this year the City Council approved a development reimbursement agreement with Maverik to provide for a signalized intersection with replacement of the damaged roadway at Commerce and Newville Road.

#### **DISCUSSION**

Caltrans' COA for Maverik's proposed development include widening of the southbound Interstate 5 off-ramp at Exit 619 to provide for a dedicated right-turn lane. The City's ad hoc committee – two Councilmembers appointed to meet with City Staff for this purpose – determined that the City also desires to have an additional east-west lane on Newville between the off-ramp and Commerce, parallel to and in addition to the existing left-turn and thru-traffic lanes. Construction of this additional lane will require certain drainage and road shoulder improvements, resulting in a dedicated right-turn lane from westbound Newville to northbound Commerce complete with pedestrian facilities including curb, gutter and sidewalk.

The City anticipates additional development in this immediate vicinity in coming years and would require fair-share contributions by future development per traffic study-designated share of traffic counts. The draft proposed development reimbursement agreement includes an obligation on Maverik Inc. to construct improvements at the off-ramp and on Newville Road now, as part of its

development project and in concert with construction of its retail refueling facility on Commerce Lane.

To share the cost, the agreement obligates the City to reimburse Maverik or its assigned contractor (upon completion of the project) \$450,0000 to cover most or all of the expected cost of the Newville improvements and to contribute substantively toward the off-ramp improvements. It is felt that these projects will improve public safety and traffic flow and will encourage further economic development in this area of Orland.

This agreement is in addition to the agreement approved earlier this year addressing Newville/Commerce intersection improvements. The cost share for this agreement will be drawn from existing Development Impact Fee (DIF) funds contributed by others for Transportation, and potentially from ARPA funds.

The agreement provides that future DIF revenues from related development (impacts on this off-ramp) occurring over the next ten years would be reimbursed to Maverik for a combined total up to the actual costs of the off-ramp project or the engineer's estimate (whichever is less) but not to exceed Maverik's traffic-study specified cost share (14.7% for the off-ramp).

The City's portion can also potentially be reimbursed in a like manner.

THIS OFF-SITE CONSTRUCTION REIMBURSEMENT AGREEMENT is made and executed on \_\_\_\_\_, by the City of Orland, a municipal corporation of the State of California (City), and Maverik Inc., a developer, whose address is 1014 South Washington Street Afton, WY 83110. (Developer).

**W I T N E S S E T H:**

WHEREAS, Developer intends to construct a fueling station with store and food service within the City at 4483 Commerce Lane, Orland, CA (Project). The Project will require and/or benefit by off-site construction improvements as follows:

Improvement Project 1: installation of an additional I-5 southbound Exit 619 off-ramp lane leading to Newville Road.

Improvement Project 2: installation of a third lane, paralleling northerly the existing thru-lane and the existing left-turn lane, on Newville east-to-west between the off-ramp and the signalized Commerce intersection, complete with pedestrian improvements including curb, gutter and sidewalk.

WHEREAS, the Off-Site Construction Improvements for Improvement Project 1 (Off-ramp) are set forth in Exhibit 1-A. The location of the Off-Site Construction Improvements for Improvement Project 1 is set forth in Exhibit 1-B.

WHEREAS, the Off-Site Construction Improvements for Improvement Project 2 (Newville Road) are set forth in Exhibit 2-A. The location of the Off-Site Construction Improvements for Improvement Project 1 is set forth in Exhibit 2-B.

WHEREAS, the Off-Site Construction Improvements for Improvement Project 1 and for Improvement Project 2 shall be undertaken and completed according to applicable City of Orland and CalTrans specifications.

WHEREAS, upon completion of the Off-Site Construction Improvements for Improvement Projects 1 and 2, and approval thereof by the City, and in accordance with Orland Municipal Code (OMC) sections 13.04.220 and 13.04.240, Developer will be entitled to be reimbursed for a portion of the Off-Site Construction Improvement for Improvements Projects 1 and 2 at the time, in the amount, and in the manner required by the OMC and this Agreement.



WHEREAS, in addition to, but separate from the enumerated and specific reimbursement provided herein, Developer will be entitled to receive any I-5 southbound off-ramp-related developer impact fees collected by the City from any and all other development with a traffic study-designated incremental impact on the subject off-ramp, for a period of ten (10) years from the date of this Agreement.

NOW, THEREFORE, in consideration of the premises set forth above, City and Developer agree as follows:

1. Developer has or will incur costs for constructing and installing the Off-Site Construction Improvements for Improvement Project 1 as set forth in Exhibit 1-A and located as depicted in Exhibit 1-B, both of which are attached hereto and by this reference incorporated herein. Developer has or will incur costs for constructing and installing the Off-Site Construction Improvements for Improvement Project 2 as set forth in Exhibit 2-A and located as depicted in Exhibit 2-B, both of which are attached hereto and by this reference incorporated herein.
2. Upon completion of the Off-Site Construction Improvements for Improvement Projects 1 and 2, and approval thereof by the City, Developer shall be reimbursed by the City in the amounts set forth in Exhibit C.
3. Such reimbursement by City to Developer shall be made in a single lump sum payment upon acceptance of the completed Off-Site Construction Improvements of Improvement Projects 1 and 2; provided, however, the total amount of such reimbursement shall not exceed the Eligible Reimbursement set forth in Exhibit C.
4. In addition to, but separate from the reimbursement provided in Exhibit C, Developer will be entitled to receive any I-5 southbound off-ramp-related developer impact fees collected by the City from any and all other development with a traffic study-designated incremental impact on the subject off-ramp, for a period of ten (10) years from the date of this Agreement. These sums, if any, shall be payable by the City to Developer within 90 days from receipt by the City. Upon request, Developer shall be provided with the relevant account information. The total reimbursement shall not exceed values stated in Exhibit C. .
5. All revenues to be paid and remitted by City to Developer pursuant to this Agreement within sixty (60) days of the acceptance of said improvements and shall be sent to Developer at Developer's address as hereinbefore set forth in this Agreement or such other address as has been filed by Developer in writing with Orland City Hall.
6. This Agreement and the benefits hereof shall not be assigned except upon written approval by the City.
7. This Agreement constitutes the entire understanding between City and Developer as to the matters set forth herein, and neither City nor Developer shall be bound by any terms, conditions, statements or representations, oral or written, not contained herein. Moreover, this Agreement shall not create any debt or obligation on the part of the City, save and except for the

obligation to pay and remit the sums provided for by this Agreement.

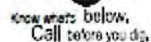
